- the provision of health care that is solely for the purpose of creating protected health information for disclosure to a thirdparty.

• **Right to withdraw this authorization** – You understand that if you want to cancel this authorization, you must do so in writing. To obtain a form to cancel this authorization, you may contact the Medical Records department. You understand that your cancellation will not be effective as to uses and/or disclosures of your health information that the person(s) and/or organization(s) listed above have made prior to the receipt of your cancellation form. You understand that if the authorization was obtained as a condition of obtaining insurance coverage, other law provides the insurer with the right to contest the claim under policy or the

records whose confidentiality is protected by federal law. Federal regulations (42 CFR Part 2) prohibit you from making any further disclosure of it without the specific written consent of the person who is the subject of such information or as otherwise permitted by such regulations. A general authorization for the release of medical or other information is NOT sufficient for this purpose.

Your rights with respect to this authorization:

- **Right to receive copy of this authorization** – You have the right to receive a copy of this authorization.
- **Right to refuse to sign this authorization** – You have the right to refuse to sign this authorization. The person(s) and/or organization(s) listed above may not condition treatment, payment, enrollment in a health plan or eligibility for health care benefits on your decision to

policy itself.

- **Right to inspect a copy of the health information to be used or disclosed** – You understand that you have the right to inspect or copy (may be provided at a reasonable fee) the health information you have authorized to be used or disclosed by the authorization form. You may arrange to inspect your information or obtain copies of your health information by contacting the Medical Records department.
- **HIV test results** – Your HIV test results may be released without your authorization to persons/organizations that have access under WI law and a list of those persons/organizations is available upon request
- **Mental health treatment records** – You have the right to inspect and receive a copy of your mental health treatment records to the extent required by HFS 92.05 and 92.06 of the Wisconsin Administrative Code.
